DRAFT MOTION BY THE PARLIAMENT OF ST. MAARTEN

January 14 2014,

Considering:

- That the Parliament of St. Maarten considers community development an important aspect of the progress of St. Maarten;
- That the government of St. Maarten is developing a National Development Plan;
- That the owners of 3 parcels of lands located in Middle Region, comprising of certificates of ad measurement numbers: 136/1988, 137/1988 and 135/1988 have indicated in several correspondences to the government of St. Maarten, their interest to sell these parcels of land to Government in order to develop a community center;
- That the only requirement of the heirs is that the community center be named after the late "Mrs. Sentor Bovina Ellis" from whom the sellers acquired the lands;
- That the Minister of Finance when presenting the draft budget during the central committee meeting has indicated that the capital borrowing ability of the Government is below the interest bearing norm.

Resolves:

- 1. To request the Government of St. Maarten to explore the possibility of acquiring these three (3) parcels of land in 2014;
- 2. To request the Government of St. Maarten to research if these lands can be acquired through the use of the capital expenditures part of the budget 2014, making use of the space in the interest bearing norm;
- To request the government of St. Maarten after successful completion of the negotiations with the owners of the parcels of land, to present a budget amendment to Parliament to make the purchase of these parcels of land a reality;

4. To request the Government of St. Maarten to take specific note of the request of the owners of the land to have the community center which will be built on the parcels of land named after the late "Mrs. Sentor Bovina Ellis".
