

The letter is self-explanatory.

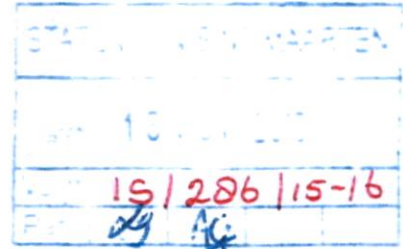

Subject: Request for explanation on case of Airport Director Regina Labega

Honorable Prime Minister Gumbs,

By means of letter, I request in my capacity as Member of Parliament representing the United People's (UP) party a thorough explanation of the procedures and facts related to the case of Princess Juliana International Airport Managing Director Regina Labega.

There has been much talk and speculation in the community about this matter and I believe it is high time the entire procedure, from its inception to date, be explained in detail for a better understanding and awareness.

I want to be informed of, among the other details, whether or not the screening of the Managing Director was stipulated by law. If yes, which laws and what was the procedure followed. If no, why and on whose authority was the screening carried out. Also, outline in the explanation why the certificate that must be issued by the Prime Minister to Ms. Labega as a person of confidence was reportedly withheld and on what grounds, if such is indeed true.

I want to also know the role of the airport's boards (both of the Holding Company and Operating Company) in the screening process and subsequent handling of the position of the Managing director.

Please note that this letter calls for a thorough and step-by-step explanation of the process regarding Ms. Labega and not only answer to the specific questions posed in this correspondence.

I require the requested information as soon as possible or at the latest within one week of the date of this letter.
