**Subject: Request for information on residence permits**

Dear Chairwoman Wescot-Williams,

Through this medium, I am requesting information from the Ministry of Justice about the refundable residence permit fees.

Needed prior to the budget debate in the Central Committee of Parliament on Monday, February 8, is the amount collected in refundable residence permit fees, the number of persons that amount represents, and the number of person who have requested their refund.

In addition, a breakdown of the number of vehicles in government's fleet that are rented, leased or in full ownership is requested from the Minister responsible for Facilities Management and/or the Minister of Finance.

This information is vital to my preparation for the upcoming budget debate.
