Subject: Collective dismissal Maho Employees

Honorable President Wescott-Williams,

It was recently brought to my attention by a group of concerned employees of the Maho Group of companies, that the management has received the approval from the labor department to proceed with collective dismissal. On June 9th, 2016 the employees received a merged Termination & Labor agreement document accompanied by a memo from the Assistant General Manager Mr. Jack Schultz, informing employees that their current labor agreement would be terminated and they would transition into a new company. In addition Mr. Schultz's, memo further states "All contracts must be signed by Wednesday June 15th, NO EXCEPTIONS".

It is with great dismay, I have taken notice of the actions of the Maho Group of companies with regards to the aforementioned. Therefore I am of the opinion that the management's unilateral decision to terminate the labor agreement of the employees without providing them with the labor department's decision. Goes against the principle of "Collectief Ontslag & Toestemming beëindiging arbeidsovereenkomst" of the civil code.

In light of my abovementioned concerns, through you I would like to submit a formal request to the Minister of VSA, the honorable Mr. Emile Lee to provide me with a response to the following:

- Has a request for collective dismissal been submitted by the Maho Group of companies
- How many employees is the Maho Group requesting to dismiss
- Has the labor department granted permission to the Maho Group for collective dismissal
- As per what date has the collective dismissal been approved
