Dear Mr. Chairman,

Information has been brought to the attention of the Permanent Committee of ECYSA of Parliament by representatives of the Charlotte Brookson Academy (CBA), currently housed at the University of St. Maarten in its third rental contract, pertaining to its current situation and challenges moving forward.

During the last CECYSA meeting with the USM the issue of CBA's usage of the facilities was brought forward and it was publicly stated that their contract would only be renewed until December 2015. As a result hereof a panic has been created within the minds of the students, parents and staff, while the Board continues to seek solutions to this predicament.

One of the issues brought forward was the inability to meet with the Interim Minister of Vromi in order to continue discussions as pertains to long lease land for the school. The board of CBA would also like to know what the Ministry of ECYS plans are as pertains to the continuity of the school.

I hereby, through you Mr. Chairman, request that the Ministers responsible provide information to this committee in regards to the abovementioned:

- 1. What are government's plans as it concerns the continuity of the Charlotte Brookson Academy which focuses on the Perfomance Arts?
- 2. What are government's intentions as it pertains to assistance to the institution in regards to the provision of long lease land?

Seeing the time constraints with the start of the new school year being around the corner, and concrete plans being needed for the continuity of the school year 2015-2016 hanging in the balance, it is hoped that this information can be provided within one week.
