Subject: Questions to the Minister of Tourism, Economic Affairs, Transport & Telecommunication (TEATT) concerning the state of affairs of Princess Juliana International Airport (PJIA).

Dear Minister,

In my oversight role as a Member of Parliament, I pose the following questions to you with the aim of gaining further insight on the state of affairs of the Princess Juliana International Airport (PJIA).

Questions:

- 1. What is the present financial situation of the airport? Specifically with regards to liquidity to pay personnel (payroll), service providers, contractors, loans and taxes and social premiums for the coming months?
- 2. What is the current status of payments to the bondholders? Is PJIA in default? If yes, to what degree and what are the consequences?
- 3. What is the current status of the insurance payout based on the court case? How much has PJIA received to date? How much is pending? What are the next steps to finalize this matter?
- 4. In an article in The Daily Herald on October 24, it is stated that "the Bondholder concerned about instability. Geerlings said the bondholders are concerned about the motion of no confidence against five ministers which was passed by Parliament on September 26, and whether the incoming interim government will honor the agreements with the World Bank and the ElB or instead seek to reverse them. The motion of no

confidence also instructed the caretaker Council of Ministers not to enter into any contracts with third parties, whether collectively or individually. The World Bank and the EIB are considered third parties."

What steps have you, the care-taker government and the National Recovery Project Bureau (NRPB) and PJIA taken to remedy this situation?

- 5. What is the status of the agreement between Government and the Bond holders with regards to the PJIA reconstruction and liquidity financing? Do the Bond holders require a declaration of Parliament before they will sign?
- 6. What is the status of the agreement between the Government and the World bank/EIB with regards to the PJIA reconstruction and liquidity financing?

I would like to receive the responses to the above questions in writing and to be answered orally in a question hour in accordance with article 69 of the Rules of Order of Parliament.
