#### **Subject: Questions to the Minister of VSA**

- 1. What is the current status of the hospital construction project? When will it begin?
- 2. What are the real construction costs of the new hospital?
- 3. How many companies or entities of government are participating in financing the new hospital?
- 4. How is the hospital paying back, and over what period of time?
- 5. Can INSO operate outside the European Union, now that Condotte is receiving Italian government support to keep them afloat. Can the minister provide proof that it can?
- 6. Why is Inso looking for a buyer?
- 7. The government support (to Condotte/Inso) was only applicable for 6 months, this was until May 2019. If there is no buyer, what happens to Inso?
- 8. Are there any interested parties now looking to buy Inso? Can we get a list?
- 9. Has a due diligence been done on Inso by any independent organization? Doesn't the minister think one should be done?
- 10. What is the opinion of the financiers? Each one of the financiers should be an expert on the situation of Inso.
- 11. What would be the consequences of not increasing the tariffs for SMMC?
- 12. If the financiers do not to proceed with Inso, would this contract be put back to public bid, or to the next company of the original tender (Vamed)?
- 13. Are there clauses in the Inso contract that protects against cost overruns?

- 15. Can MPs get the documents of the bid from Inso?
- 16. Can the minister guarantee that come what may, that Inso will be able to fulfill its contractual obligations? Or can minister confirm that there is a possibility that Inso will not bounce back?
- 17. The contract for building and maintaining the hospital is 135 million. How can you assure that Inso can comply with its maintenance obligations years from now even if they can build it now?
