- 2. Has any bidding been carried out for these demolition projects? If yes, which company(ies) won the bids and what are the contract amounts?
- 3. What is the status of the Long Lease land impasse with Mr. Denisio Wyatt for the pieces of land with certificate admeasurement numbers 109/2009, 179/1989, 323/1971, 93/1971, 69/1978 and the border with Retreat Estate? Will this land be given to Mr. Wyatt in long lease?
- 4. What is the status of the building permit request by Mr. Lee Halley based on the signed rental agreement with Government represented by the former Minister of VROMI Christopher Emmanuel and Lee's Road side Grill & Bar N.V. in 2017, for a parcel of land on Simpson Bay beach, also known as Kimsha beach with the besluit number 0288/2000 on May 22nd, 2000.
