Dear Chairman of Parliament,

I would like you to pay keen attention and give some consideration towards my person as Member of Parliament requesting the following information.


Mr. Chairman, I want to bring to your attention the United Nation's General Assembly Resolution 66(I). The Resolution adopted by the General Assembly on December 14th, 1946. This Resolution formation from Non-Self-Governing territories transmitted from under article 73 of the Charter.

I am hereby asking for your consideration in requesting through the Prime Minister, via the office of the Minister of Plenipotentiary for the Netherlands to show via a Resolution where when we, the Netherlands Antilles, were removed from the list of Non Self-Governing territories. Mr. Chairman, I ask this in relation to the current situation that is unfolding right now, where on a constant basis it is being said that the islands of the Netherlands Antilles were removed from above mentioned list.

Based on this resolution, adopted by the General Assembly on December 14th, 1946, where it clearly states that the General Assembly also notes that the following governments have declared their intention of transmitting information. Belgium on the Belgian Congo; Denmark on Greenland; The Netherlands on the Netherlands Indies, Suriname and Curacao.

Mr. Chairman I am asking for your keen attention to forward this information to the Prime Minister and the office of the Minister of Plenipotentiary. As I reiterate, for the Netherlands to show where we, the Netherlands Antilles, were removed from the list of Non Self-Governing territories.
