#### Honorable Minister Panneflek;

As a result of the challenges we face from COVID-19, the country is now confronted with numerous complaints of labor abuse against employees of a number of companies such as Little Switzerland and the Towers at Mullet Bay, just to name two. The employees' complaints amount primarily to not being dismissed and still not being paid. Our labor laws are clear and specific when it pertains to the dismissal procedures, yet these are not being adhered to by some companies.

The social and economic effects these actions by some employers will have on our country can be devastating. Sending employees home with very little financial means will most certainly result in unwelcome civil unrest, which the country does not want at a time that we are trying to preserve our season. Some companies are transferring their assets to their sister companies overseas and leaving their employees here stranded.

In view of the above, through this medium, I request clarification and where possible direct action on the following:

- What is the role of the Inspectorate of labor in these cases?
- How successful is the labor office in assisting employees who have fallen victim to employers who wrongly dismiss them without adequate compensation?
- Why is the government seeking legal advice against the owner of The Towers at Mullet Bay instead of issuing the employees a yellow card? The case against the owner of the Towers at Mullet Bay can be costly and may drag on over a lengthy period of time.
