Honorable Minister,

Our beautiful nation St. Maarten was literally built on the backs of our fore fathers. From the salt trade to our present day Tourism. All can be traced back to our seniors.

Yet, today our seniors are often taken for granted. It is my hope that with your help we can implement a senior friendly program via the 100% Gov't owned company GEBE. Approximately 10 years ago the UP lead government required GEBE to implement a Senior relief subsidy. This was to eventually become a full-fledged tariff. That has never happened although GEBE has budgeted this relief annually.

I am hereby requesting that this subsidy be turned into a fixed tariff for seniors. The tariff can be called Tariff 60 for all citizens that are 60 and over. It can be given to all seniors place of residence. The tariff should encompass both electricity and water.

For your reference and consideration:

1. The electricity concession of July 12, 2010.

Article12 of the concession on page 8: "Op grond van sociale overwegingen kan voor bepaalde

categorieen gebruikers van volledige toepassing van het principe van kostenorientatie worden afgewerken. Daarbij kan worden gedacht aan lagere tarieven voor kleine gebruikers "

2. GEBE budget

Chapter 9, Page 20, Provision Pensioners. GEBE has already approved Naf 500,000 towards senior relief.

3. Pricing Ordinance of St.Maarten

The Ministry of Teatt has been the ministry in the past that implements and approves GEBE tariffs. This can also be traced back to the last tariffs that was conditionally approved on June 15,2011, number 793/11 using article 2 of said ordinance.

I do not see any reason that this request cannot be finalized before Christmas 2021.

I do hope that I have provided you with all the relevant information to make this initiative come true.
