RE: Questions on School Eye Health

Dear Minister Samuel,

I believe that "if you struggle to see, you struggle to learn." Although we may not have the data, I am aware of the fact that a number of our children struggle with vision impairment and conditions that cause eye damage and blindness like uncorrected refractive errors, trachoma, vitamin A deficiency disorders (VADD) and cataracts. Over the last few years I have bought glasses for children and young people who cannot afford them and there must be more.

In 2018, the Lion's Club launched a project called the "Lion's Eye Screening" which had a budget of almost USD\$24,000 raised through international fundraising and connected with nineteen (19) optometrists from the United States that visited St. Maarten to volunteer optometric services for all primary school students in groups 3 to 8. Those who needed glasses received a free pair through this project. I was a policy advisor at the Department of Education at the time. I do not believe there has been a similar project since.

Integrating eye health into our education systems will improve the quality of education for those students who are fighting vision impairment but whose families cannot afford prescriptive eye wear. Because glasses are so expensive, it is not only practical but efficient to create a sustainable private-public partnership with key partners on the island who may be willing to assist those most vulnerable students who desperately need the help. I would propose that the Ministry reach out to the Lion's Club or the American University of the Caribbean to engage in such a partnership.

In regards to school eye health and the above-mentioned, I would like to inquire about the following;

- 1. When was the last time the Ministry was informed of any eye screening projects at the schools?
- 2. Is the Ministry collecting any school and student data on eye health in particular? If yes, can you please share this information? If no, is it something that can be done.
- 3. Is the Ministry aware of any school boards who implement eye health programs? If yes, can you please share which school boards and a short description of said program.
- 4. Do students at Prins Willem Alexander School (PWAS) receive regular eye exams?
- 5. Does (PWAS) school management pay particular attention to eye health and are there any concerns regarding eye health that have been registered with DPE?

- 6. Would it be possible for the Ministry to launch a private-public partnership with interested NGOs to not only assess current eye health in schools but also create a program where vulnerable students can receive free eye wear? If yes can the project also include the Ministry of VSA?
- 7. Do you believe that eye health should be integrated into the curriculums and general school health programs?
