Honorable Minister Irion,

By letter of November 19, 2020, you informed the Association of Psychologists and Allied Professionals on St. Maarten of the ongoing efforts to rectify an omission in the Turn-Over-Tax legislation, namely that presently, unlike their professional care colleagues, psychologists etc. are not exempted from paying Turn-over-Tax.

At the time of your letter (November 2020), ref. no. 2954-A, you apprised the association of the further process, as the advice from the Council of Advice was received and needed to be reacted on. It is several months now that representatives of the association have approached me regarding a possible initiative amendment to rectify this unfair situation, which exists for years.

Reviewing the Council of Advice's site, I have concluded that the request to the Council of Advice for advice on this draft dates back to February 2019.

Given the time that this matter has taken, I kindly ask that you inform me post haste of the following:

- 1. Has Fiscal Affairs drafted the further report and has the Council of Ministers approved same?
- 2. If not, why not?
- 3. If yes, when was this done?
- 4. When will the parliament receive an amendment to the Turn-over-Tax ordinance, rectifying this omission?
- 5. Will/can this matter be corrected retroactively, given the unequal treatment endured by the professionals in question, especially given the stressful environment in which all our medical professionals operate due to the Covid-19 pandemic?
